## GENERAL TERMS AND CONDITIONS OF SALE

The General Terms and Conditions of Sale govern all sales of holidays made on the website: [www.campingauxrivesdulac.com](http://www.campingauxrivesdulac.com), by post or any other means, and form an integral part of any contract concluded between the campsite and its customers.

Minors unaccompanied by their parents are not admitted (except in the case of a camp or group supervised by responsible leaders, and after acceptance by the campsite).

You must adhere to our house rules which are displayed at the entrance of the campsite and are available on request at the reception.

Each client acknowledges having read these General Terms and Conditions of Sale prior to booking a holiday (for themselves or any other person taking part in the holiday). The General Terms and Conditions of Sale are made available to you for information purposes. You can obtain them on request from the campsite.

All prices are quoted in Euros including VAT (10%).

Payments :

- Online : CB, bank transfer, cheque
- On the spot : CB, cheque, cash, ANCV

All payments received from us are deemed to be acceptance of the order (subject to the proper processing of other payments).

All reservations are non-transferable.

**WITHDRAWAL** : The legal provisions relating to the right of withdrawal in the case of distance selling as set out in the Consumer Code do not apply to tourist services (Article L.121-20-4 of the Consumer Code).

**LIABILITY** : The campsite declines all responsibility for damage to the equipment of the tenant of the accommodation or pitch which is of his own making (insurance for your equipment in respect of liability is compulsory).

### **MISCELLANEOUS** :

Tents, caravans and motorhomes are not allowed near the accommodation.

In our accommodation rental rates, electricity, gas, water, a vehicle and the number of people indicated are included.

Any person exceeding the capacity of the accommodation or any other service not included in the package will be charged.

In the event of non-compliance with the rules and regulations, the campsite reserves the right to cancel the stay and to force the participants to leave the premises, without any refund.

## **ACCOMODATION**

### **Mobile home, Coco Sweet**

#### **ACCOMODATION HOURS :**

**All year round : Arrival from 4:00 pm to 6:00 pm and Departure before 10:00 am**

The rental will be effective only after our agreement and after reception of the total amount of the stay and the reservation fees.

At the order : 30% of the stay + booking fees of 13.00 €.  
The BALANCE 10 days before the arrival.

On your arrival, you will be charged and collected the tourist tax and the environment package.  
In case of late arrival without notice, the rental will become available the day after the arrival date stated on the booking contract. After this period, the booking will be void and the sums paid will be retained by the campsite. No reduction will be made in case of late arrival or early departure.

Last minute rental (less than 10 days before arrival) full payment by credit card at time of booking.

DEPOSITS and payments on arrival : Deposit 250.00 € for damage, loss or damage etc on the equipment, and 60.00 € for cleaning, amounts returned at the end of the stay, after inventory of fixtures (before 10 am). The invoicing of possible degradations will come to be added to the price of the stay as well as the cleaning if you do not leave the accommodation in a state of perfect cleanliness.

## **PITCH**

### **Pitch for caravan, motor home or tent**

#### **PITCH HOURS :**

**All year round, Arrival from 2:00 pm to 6:00 pm and Departure before 12:00 pm**

The reservation of a pitch is nominative and cannot be transferred.

The reservation of your pitch will be effective only after the payment of a fixed deposit of 19.80 € + reservation fees (3.00 €) and 16.80 € for customers holding the ACSI card, + reservation fees (3.00 €).

#### **Classic pitch :**

Package 2 persons and with electricity, for :

1 motor home, or 1 caravan and 1 vehicle, or 1 tent and 1 vehicle.

#### **Hiker pitch :**

Package 1 person without electricity, for :

1 small tent without car (on foot, bike or motorcycle)

With supplement, possibility of a maximum of 3 persons, 1 animal and electricity.

**CANCELLATION :** All cancellations by the client must be made in writing (registered mail or e-mail).

- More than 10 days before the arrival date the deposit and the booking fees will be retained by the campsite.

- Less than 10 days before the date of arrival, the total amount of the rent will be due, and, the entirety of the sums will remain acquired to the campsite.
